# TRAVELLING TO SPAIN - VACCINATED

STEP	WHAT	How	WHY?
#1	Join the WhatsApp Group	<a href="#">Click Here</a> - Password Tennis2022	To connect with other clients and coaches on your trip
#2	Download your Itinerary	<a href="#">Click Here</a>	So you know the key timings
#3	Check your Vaccine Status	<a href="#">Click Here</a>  At least 14 days must have passed since being fully vaccinated (with both doses of a 2-dose vaccine or one dose of a single-dose vaccine) before arrival in Spain. Your date(s) of vaccination must be specified and your final dose must have been administered within 270 days prior to travel to Spain. If you completed your vaccination (with both doses of a 2-dose vaccine or one dose of a single-dose vaccine) more than 270 days prior to travel to Spain, you must be able to show proof of having received a booster jab. There is no requirement for 14 days to have passed between receiving your booster jab and entering Spain. Booster jabs can be administered at any time prior to travel to Spain.	
#4	Download your Vaccine Certificate	Follow the instructions <a href="#">here</a>	You must present this when Checking In at the Airport and/or on arrival
#5	Purchase a Mask	The use of face coverings is mandatory for anyone over the age of 6 years old on all forms of public transport in Spain and in many other indoor public spaces.

#3	Complete PCR or Antigen Test	Documentation certifying that you have undertaken a diagnostic test and tested negative within 72 hours of entering Spain if using a COVID-19 nucleic acid amplification test - NAAT (PCR or similar), or 24 hours if using an antigen test.	
#4	Complete PLF Form	<a href="#">Click Here</a>	For entry to Spain
#5	Purchase a Mask	The use of face coverings is mandatory for anyone over the age of 6 years old on all forms of public transport in Spain and in many other indoor public spaces.
